- Call to order: The meeting was called to order at 10:30 a.m. by Mary Beth Siddons, Vice President.
- Certify a quorum: With 5 of the 5 Board members present, a quorum was established.
- **Certify meeting notice**: The meeting notice was posted in accordance with Florida Statutes and the governing documents of the Association.
- **Approval and Disposal of Previous Minutes:** Gordon Taylor made a motion to waive the reading and approve the Board Meeting Minutes from March 26, 2025 as written. Motion seconded by Gary Leidheiser; motion passed UNANIMOUSLY.

## • Vice President's Report:

- o Board members participated in the state required 4-hour Board Certification Class. Board members were asked to send Jami Herter their certificates of completion to post to website.
- A Special Board of Directors meeting is scheduled on May 28, 2025 to discuss and vote on levying a Special Assessment to increase villa reserve funding. Immediately following there will be a Special Membership meeting for villa owners to vote on the Special Assessment.
- o Single-family owners with swimming pools were asked for their feedback on having ArtisTree maintain the shrubs around pool cages.
- Landscaping committee will be obtaining estimates for sod replacement. Owners should submit their requests before June 1<sup>st</sup>.

#### • Treasurer's Report:

- o Income and expenses are tracking as expected. Year-to-date income through March 31st is \$10,120.
- Accounts Receivable for 10 owners ranging from \$10 \$129.
- o Capital contributions were \$995.
- Manager's Report: Dog park drainage was completed. Fencing was completed by Englewood Fencing,

- o Infrastructure Committee: Reported they are looking into replacing lights at the pool cabana. Estimates for sidewalk repairs will be obtained as soon as possible.
- Tree Trimming in Xeric Hammock Preservation Area: Tabled.
- Englewood Fencing: Change order for more extensive repairs of \$2,500 was reviewed. Motion made by Gary Leidheiser to approve. Motion was seconded by Gordon Taylor; motion passed UNANIMOUSLY.
- **Architectural Review Applications:** Gary Leidheiser made a motion to approve the architectural review applications for 2235 Terracina Drive/exterior painting and roof shingle replacement; 2204 Terracina Drive/roof shingle replacement; 2521 Terracina Drive tree removal. Motion was seconded

by Rich Barile; motion passed UNANIMOUSLY. Approval letters with more detail and conditions, if applicable, will be forthcoming from Access Management.
