- 1. Call to Order: The meeting was called to order at 10:34 am by Jodi Mercer, President.
- 2. Certifying of Proxies and Registration of Owners: Jami Herter-LCAM certified the proxies received by mail or by delivery and registered Owners in attendance.
- 3. **Proof of Proper Notice of the Meeting:** A 14-day Notice for a Special Membership Meeting of Villa Owners was mailed to all Villa Owners/Members by U.S. Mail and posted in accordance with Florida Statutes and the governing documents of the Association.
- **Determination of a Quorum:** Jami Herter-LCAM certified that with 69 Villa Owners/Members in attendance in person or by proxy, a quorum was established.
- 5. New Business Membership Discussion and Villa Owner Vote on the following question:
 a. PURSUANT TO SECTION 9.3 OF THE DECLARATION OF COVENANTS, CONDITIONS,
 RESTRICTIONS AND EASEMENTS FOR VERONA RESERVE, DO YOU APPROVE THE
 LEVYING OF A VILLA SPECIAL ASSESSMENT AGAINST ALL VILLA LOTS IN THE
 TOTAL AMOUNT OF \$408,000.00? Discussion was held and all Villa Owners in attendance had an
 opportunity to ask questions or comment. Ballots were completed by Villa Owners in attendance and Jami
 Herter counted the votes of the ballots and proxies. There was a total of 69 votes, of which 50 Villa Owners
 voted to approve the special assessment and 19 Villa Owners voted to disapprove the special assessment.
 With over a 2/3 majority of Villa Owners voting in person or by proxy, the special assessment was
 approved.
- **6. Adjournment:** Rich Barile made a motion to adjourn the meeting at 10:47 a.m. The motion was seconded by Nancy Smith. A voice vote was taken and all were in favor. Meeting was adjourned.
